Borough Reorganization Meeting
Monday, January 5, 2026
Minutes

The biannual reorganization meeting of the Borough Council was held on the above date in the Municipal Office, 214 Main Street, Green Lane. The Honorable Mayor Rick Stamper called the meeting to order at 6:30 p.m., and the Pledge of Allegiance was recited. Prior to the meeting, Mayor Stamper had administered the oath of office to the newly re-elected Borough Council members Brian Carpenter and Darren Landis, each for a four-year term.

NOMINATION AND ELECTION OF PRESIDENT: Mayor Stamper entertained a motion of nomination for Brian Carpenter as President of Borough Council by Gerald Godshall with second by Darren Landis. Motion carried.

NOMINATION AND ELECTION OF VICE PRESIDENT: Mayor Stamper entertained a motion of nomination of Gerald Godshall as Vice President of Borough Council by Councilman Landis with second by Jack Findley. Motion carried.

NOMINATION AND ELECTION OF PRESIDENT PRO TEM: Mayor Stamper entertained a motion of a nomination for Jack Findley as President Pro Tem (to serve as President in the event of the absence of the President and Vice President) by Councilman Glass. Second by Councilman Landis. Motion carried.

At this point, Mayor Stamper handed over leadership of the meeting to President Brian Carpenter.
