**STATEMENT OF LIABILITY**  
**(Please read carefully before signing.)**

Isaac Smith Park is a facility of the Borough of Green Lane and as such its use and maintenance is within the jurisdiction of, and regulated by pertinent Borough legislation. This legislation, specifically Ordinance No. 86-2 enacted by the Borough Council of the Borough of Green Lane on April 7, 1986, and specifies, in pertinent as follows:

(1) Persons renting or otherwise utilizing park facilities do so at their own risk. Such persons understand that the liability for any property damage or personal injury occasioned by their use of the facilities, whether such damage or injury be to themselves, their guests or third persons, is strictly theirs and that by signing this document they agree to save harmless the Borough, its elected and appointed officials, the Green Lane Fire Company its governing body and representatives, and the Isaac Smith Park Committee from any and all claims, actions causes of action or damages which might arise out of their utilization of Isaac Smith Park and its facilities.

(2) Persons renting or otherwise utilizing park facilities understand that they will be held strictly accountable to the borough of Green Lane, the Green Lane Fire Company and the Isaac Smith Park Committee for any and all damages to the park and its various facilities occasioned by their utilization thereof.

The undersigned, on behalf of themselves, the members of their party and their guests does by this signature hereto, affixed prior to his rental or utilization of the Isaac Smith Park and its Facilities, attest to the fact that they have read the above, are aware of its significance and is agreeable to being bound by the provisions thereof as well as all of the other regulations pertinent to the use of Isaac Smith Park.
