Borough Reorganization Meeting
Monday, January 6, 2020

The biannual reorganization meeting of the Borough Council was held on the above date in the Municipal Office, 214 Main Street, Green Lane. Mayor Lynn Wolfe called the meeting to order at 6:32 p.m., and the Pledge of Allegiance was recited. Mayor Wolfe swore in the newly elected Borough Council members Gerald Godshall, Jonathan Guntz and Jack Findley for four-year terms.

NOMINATION AND ELECTION OF PRESIDENT PRO TEM: Brian Carpenter entertained a motion of a nomination for Jonathan Guntz as President Pro Tem (to serve as chair in the event of the absence of the President and Vice President). Motion was made by Gerald Godshall with second by Brian Carpenter. Motion carried.
